COAH heard oral argument at its March 10, 2010 meeting regarding a motion filed by C&M Real Estate and RCM Group for an Order to Show Cause as to why Aberdeen Township will not abide by the terms of the Memorandum of Understanding executed with RCM on December 17, 2009, based upon a settlement agreement reached at COAH mediation.
