This conveyance is being made by the Grantor to the Grantee for road widening and improvement purposes.

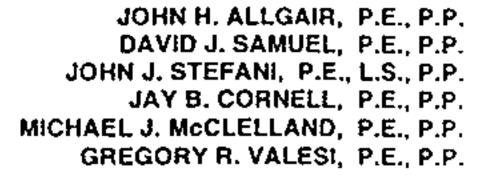

DESCRIPTION FOR RIGHT-OF-WAY ACQUISITION PURPOSES, SITUATED IN THE TOWNSHIP OF ABERDEEN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY.

Being an irregular strip of land upon and across premises known and designated as Lot 7 in Block 173 on the current Township of Aberdeen Tax Map, Sheet No. 31, and being more particularly described as follows:

BEGINNING at a point in the northwesterly right-of-way line of county Road (16.50-foot half width) where the same is intersected by the common line between Lots 7 and 8, Block 173, and from said point of beginning RUNNING:

- 1. Along the aforementioned common line North 55°-01'-44" West, a distance of 5.89 feet to a point; thence
- 2. Through Lot 7, Block 173, North 47°-08'-40" East, a distance of 51.68 feet to a point in the common line with Lot 6, Block 173; thence
- 3. Along said common line, South 43°-28'-12" East, a distance of 5.85 feet to a point in the aforementioned northwesterly right-of-way line of County Road; thence
