**DEED**

This Deed is made on APR. 5, 2001

BETWEEN MARY VIOLA REY, THELMA CECILIA REY and DAVID W. REY  
 whose address is 401 Market Street, Perth Amboy, New Jersey 08861, referred  
 to as the Grantor,

AND TOWNSHIP OF ABERDEEN  
 whose address is One Aberdeen Square, Aberdeen, New Jersey 07747, referred  
 to as the Grantee.

The words "Grantor" and "Grantee" shall mean all Grantors and all Grantees listed above.

Transfer of Ownership. The Grantor grants and conveys (transfers ownership of) the property described below to the Grantee. The transfer is made for the sum of TWO HUNDRED FIFTY (\$250.00) DOLLARS.

The Grantor acknowledges receipt of this money.

Property. The property consists of the land and all the buildings and structures on the land in the Township of Aberdeen, County of Monmouth and State of New Jersey. The legal description is:

BEING the same premises conveyed to Grantor herein by Deed from John J. Noonan to William Rey and Theresa Rey, husband and wife, dated October 1, 1928 and recorded November 26, 1928 in the Monmouth County Clerk's Office in Deed Book 1463, page 248. William Rey died on July 22, 1970 and Theresa Rey died on SEPT. 17, 1985 leaving their children, Mary Viola Rey, Thelma Cecilia Rey and David W. Rey, as their heirs at law. *MVR DR JR*

This conveyance is being made by the Grantor to the Grantee for road widening and improvement purposes.

Promises by Grantor. The Grantor promises the Grantor has done no act to encumber the property. This promise is called a "covenant as to grantor's act" (N.J.S.A. 46:4-6). This promise means the Grantor has not allowed anyone else to obtain any legal rights which affects the property (such as by making a mortgage or allowing a judgment to be entered against the Grantor).

COUNTY OF MONMOUTH, STATE OF NEW JERSEY.


Being a 1.50-foot wide strip of land upon and across premises known and designated as Lot 17 in Block 174 on the current Township of Aberdeen Tax Map, Sheet No. 31, and being more particularly described as follows:

BEGINNING at a point in the northwesterly right-of-way line of County Road (16.50-foot half width) where the same is intersected by the common line between Lots 16 and 17, Block 174, and from said point of beginning RUNNING:

1. Along the aforementioned common line, North  $55^{\circ}-03'-15''$  West, a distance of 1.51 feet to a point; thence
2. Through Lot 17, Block 174, North  $41^{\circ}-08'-45''$  East, a distance of 40.00 feet to a point in the common line with Lot 18, Block 174; thence
3. Along said common line, South  $55^{\circ}-03'-15''$  East, a distance of 1.51 feet to a point in the aforementioned northwesterly right-of-way line of County Road; thence
4. Along said northwesterly right-of-way line of County Road, South  $41^{\circ}-08'-45''$  West, a distance of 40.00 feet to the point and place of BEGINNING.
