This conveyance is being made by the Grantor to the Grantee for road widening and improvement purposes.

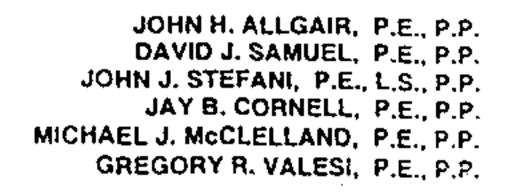
